The enclosed distribution, payable to holders of record as of November 20, 2023, has been made from the following estimated sources:

- \$.02 per share paid from undistributed net investment income earned during 2023
 - .00 per share paid from undistributed short-term capital gains realized during 2023
- 1.13 per share paid from undistributed long-term capital gains realized during 2023
- \$1.15 total
