The enclosed distribution, payable to holders of record as of February 9, 2024, has been made from the following estimated sources:

- \$.04 per share paid from undistributed net investment income earned during 2023
- .01 per share paid from undistributed long-term capital gains realized during 2023
- .05 per share paid from undistributed net investment income earned during 2024
- \$.10 Total

This does not currently represent information for tax reporting purposes. The actual amounts and sources of the distributions may change based on tax regulations and the Fund's investment experience through the remainder of its fiscal year. Shareholders will be notified regarding the

amounts and sources of all distributions for the calendar year and the related tax treatment via Form 1099-DIV in early 2025.
