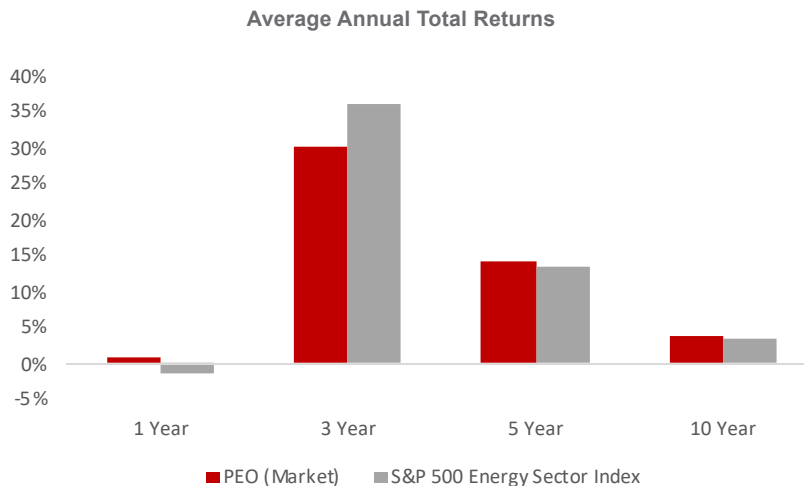

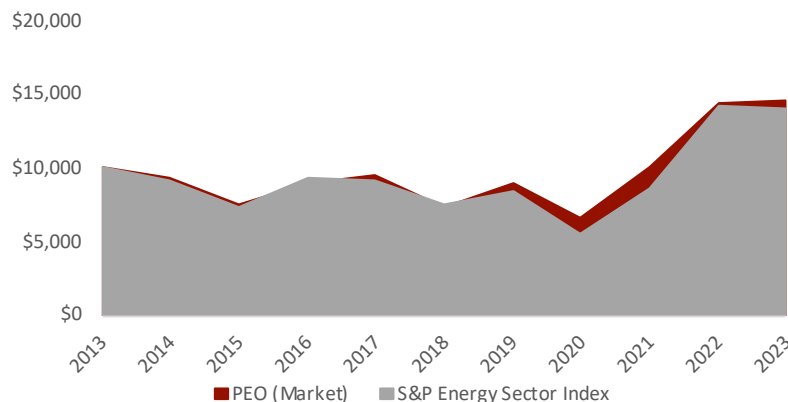

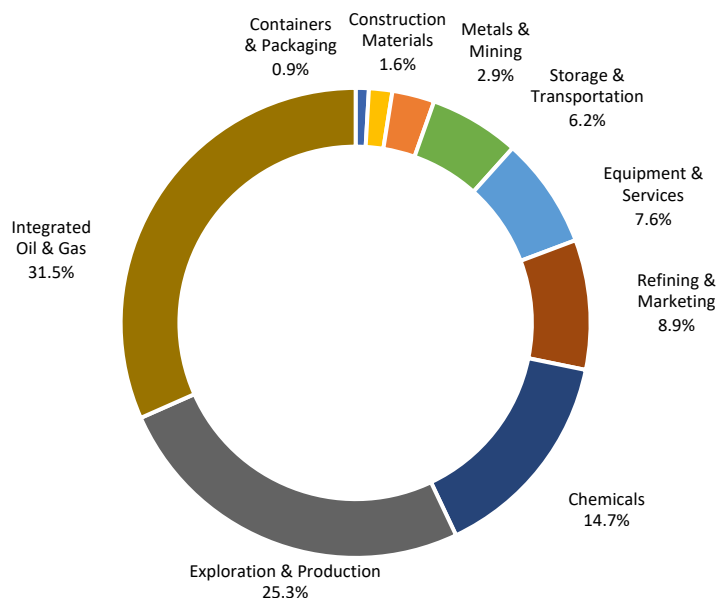
Hypothetical \$10,000 Investment
