

Adams Natural Resources Fund, Inc. (NYSE: PEO) 2024 Quarterly Distribution Payable on February 26, 2025

Notification of Sources of Distributions Pursuant to Section 19(a) of the Investment Company Act of 1940

The distribution of \$0.53 per share, optionally payable in additional shares of Common Stock or in cash by specific stockholder election, is to be paid on February 26, 2025, to stockholders of record at the close of business on January 27, 2025 (ex-dividend on January 27, 2025). The reinvestment price is \$22.43, the Fund's closing NYSE market price on February 14, 2025, the valuation date.
